- **All vehicles and/or boats require an entry fee into the park. When attendants are not on duty, please pay the Honor Boxes provided at each entrance.**
- **Picture ID is required for Season Pass purchases.**
- Season Passes are half price as of August 1<sup>st</sup> each year.
- Senior Season passes can be purchased by persons who are or turn 62 years of age or older by the end of the year.
- Each Senior is limited to one Season Vehicle Pass, or one Vehicle/Boat Combination Pass per year. Senior Season Passes are assigned to the purchaser for their personal use only.
- Season Passes may be purchased at the Park Office, either Campground or The Jesse James Bank Museum in Liberty during business hours. Call (816)407-3400 for times.
- Check, MasterCard, Visa and Discover accepted at Park Office, Little Platte and Campgrounds only.
- Non-motorized boats less than 14' in length and canoes are not required to have a pass.

## Boat Only Passes

- You still need a pass for your vehicle when launching a boat.
- This pass is an excellent choice for those that camp and have a camping vehicle pass already.
- Slip holders with a vehicle only pass and multiple boats will also enjoy this pass.

## Personal Property Taxpayer Discount

Clay County Personal Property Taxpayers will be eligible for a discount on season passes.

- **Senior Citizens Discount (62 years & older) – 3 consecutive nights paid in advance, get the 4<sup>th</sup> night free.**

- The camping fee includes one vehicle pass for the duration of your stay which will allow you access to all park entrances.
- Additional vehicles must purchase either a daily or season pass. Camping fees do not include boat passes. These must be purchased prior to launching the boat.
- Bags of ice and bundles of firewood are available for purchase.

### IF YOU EXPERIENCE AN EMERGENCY AND NEED IMMEDIATE HELP DIAL 911

When the main office is closed you can reach a Clay County Park Ranger by calling (816)407-3400, 24 hours a day.

Any of our Park personnel will be happy to help. Just look for vehicles with the Clay County emblem or go to the nearest Fee Collection station.

There are tornado shelters located next to Paradise Pointe Marina and Camp Branch Marina.

St. Lukes Northland Hospital is located ½ mile north of State Highway 92 on U.S. 169.

If you need to get in touch with the Missouri State Water Patrol, you may call (816)525-9657 and leave your name and number and they will return your call. You may also contact their main office in Jefferson City by calling (573)751-3333 or Troop A at 816-622-0800.

If you hit an animal or see wounded animals, please call the Missouri Department of Conservation at (816)271-3111. They will need to know what kind of animal it is, what happened, and the location of the animal.
