

Hunting will be prohibited in the following areas:

- **Dam:** Hunting will be prohibited on both the front and back slopes of the dam. On the front slope this area will extend out to the access roads to both the East and West Dam parking areas.
- **Sylvan Park:** Hunting will be prohibited in all of the Sylvan park area including the campground and day use area, administration area, garages, storage area and Bur Oak hiking trail. Hunting will only be permissible below Wilson Dam on lands managed by the Kansas Department of Wildlife and Parks.
- **Lucas Park:** Only Archery and Shot shell (no slugs) hunting will be permitted in the Lucas Park area except for the following two No Hunting locations: a) from the east/west boat ramp road, south. b) Southeast of the park attendant booth to the North campground loop.
- **Minooka Park:** Hunting will be prohibited in all of the Minooka park area.




Minooka Park



A Friendly Reminder to Hunters on COE Managed Land

1. **Operation and/or parking of a vehicle off authorized roadways is prohibited**
2. The **cutting** of trees and/or tree limbs is not permitted
3. **Permanent** hunting stands or blinds are not permitted
4. All garbage, trash, or any other waste must be removed from project lands or deposited in appropriate receptacles
5. Stands, climbing devices, bow hangers, etc... **can not** be screwed into trees
6. Possessing loaded firearms or any other weapons (including target shooting) while not hunting is prohibited.
7. Camping is available at Minooka, Lucas, and Sylvan Park (open showerhouse).

HUNTING POLICY




This brochure applies **ONLY** to public land managed by the Corps of Engineers at Wilson Lake

Regulations

- Hunting will be permitted on Corps of Engineers managed lands and water except for those areas designated as closed to hunting.
- Hunters will be required to follow all Corps of Engineers rules and regulations. **(A complete set of Title 36 regulations can be obtained at the information center located below the dam or at the park attendant booth at each park)**
- Hunters must follow all applicable Federal and State game laws.
- All hunters will be required to unload their firearms and keep the action in the open position while within any area identified as prohibited to hunting. Any hunter found with a loaded firearm within a prohibited area will be presumed as being actively engaged in hunting.
- Furharvesting (FH) is prohibited in all Corps of Engineer's parks (Minooka, Lucas, and Sylvan Park). Property outside of Corps of Engineer's Parks that is open to hunting is also open to FH. All FH must comply with federal and state game laws
- Hunting and FH are prohibited within a 100 feet from the shoreline of any no hunting area.
