### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The unnamed tributary has a steep gradient that is approximately 3.3% and is primarily a conveyance of water after rainfall events. It is unlikely that the unnamed tributary provides significant habitat and/or lifecycle support functions for fish and other species that are present in the Missouri River. Additional information on the lack of a significant nexus is documented below in Section F of this form.

**We determined that this tributary lacks the presence of a significant nexus to the Missouri River. Cumulatively, tributaries similar to the reach being analyzed do have a significant affect on the integrity of the nations TNWs; however, our guidance directs us to determine the significance of the functions of the single tributary for jurisdictional purposes. The beginning and end point of the tributary being evaluated is depicted by the dotted blue line on the attached documents.**

The tributary is located in a wooded property that is at the top of the local watershed and drainage to the tributary comes from a residential-type development and the surrounding wooded property. The project site is located in the Lower Missouri - crooked HUC-8 watershed. The local watershed was calculated to be approximately 550 acres which was calculated by measuring all of the drainage upstream of the nearest RPW. The nearest estimated RPW is depicted on an attached drawing and is over one stream mile from the reach being evaluated in this JD. The estimated beginning point of the RPW is based on experience regulating similar streams in the region for the past seven years and takes into account the size of the watershed, annual precipitation, expected urban runoff, and topography. The nearest TNW is the Missouri River which is approximately two stream miles away. The drainage area of this location is approximately 47 acres which is depicted on the attached drawings and was calculated by measuring the acreage that drains to the tributary and ends at the downstream end of the project boundary. This measurement was calculated using contours on the USGS topographic quad map.

The relative reach being analyzed is approximately 2 feet wide and is a 1st order tributary that forms from sheet flow immediately upstream of the project boundary. The tributary is not mapped as a FEMA designated floodplain. This information supports that the tributary flows infrequently with a relatively small volume of water. The tributary is so minor that it is not mapped on any common mapping dataset including the USGS topographic map, the National Hydrography Dataset, the Clay County Soils map (no alluvial soils are present), and the National Wetland Inventory Map.

Based on the 2006 aerial photos we determined that the drainage area of the tributary has contribution of flow from approximately 25 residential type dwellings that include yards and roads. We believe that it is speculative to determine that this residential setting can significantly affect the water quality of the Missouri River. Our analysis has shown that this particular tributary has the capacity to carry pollutants to the Missouri River; however, no pollutants have been identified onsite and we believe it is speculative as to the significance of the impacts an unknown pollutant may have on the chemical integrity of the Missouri River.

The unnamed tributary has a steep gradient that is approximately 3.3% and is relatively straight. This suggests that the tributary is primarily a conveyance of water after rainfall events. The slope also suggests that the tributary adds little value to flood retention since the tributary would likely drain quickly in a flood event. The potential for this tributary to recharge groundwater is also unlikely based on the gradient of the tributary.

It is unlikely that the unnamed tributary provides significant habitat and/or lifecycle support functions for fish and other species that are present in the Missouri River. The tributary is not critical habitat for any state or Federal listed species. The relative reach does not support a fishery. Since the tributary also drains quickly it is unlikely that the tributary supports macroinvertebrate populations that would have a significant affect on the Missouri River. .
