This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: : **The review of topographic maps and aerial photos indicated this wetland was formed from the backup of water upland of Route 150, which then drains through a culvert into a poorly defined drainage feature to the south. Because of the size of the wetland (0.14 acre), the low quality vegetaion which creates low quality of the habitat, this wetland has minimal functions. The major function that this wetland performs is sediment filtering.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The relevant reach beginning and end point of the reach being evaluated is depicted by the blue line on the attached map. The relevant reach being analyzed is a 1st order channel that forms from sheet flow immediately upland of the channel. This reach is located at the top of the local watershed and drainage to the channel comes from a agricultural fields. The drainage area for this reach is approximately 35 acres and the local watershed is approximately 300 acres. The local watershed was calculated by measuring all of the drainage upstream of the nearest RPW. The nearest estimated RPW is Oil Creek and is less than one stream mile from the reach being evaluated in this JD. Consistent with other designation, for the purposes of this determination Longview Lake will be considered the TNW. The Longview Lake is approximately 5.2 river miles from this reach. The has a slope of this reach is approximately 4% and is relatively straight. This suggests that the channel is primarily a conveyance of water after rainfall events and flow is only present for a short time after sufficient rain events. The slope also suggests that the channel adds little value to flood retention since the channel would drain quickly in a flood event. The potential for this reach to recharge groundwater is also unlikely based it's location at the top of the watershed. Although this particular reach has the capacity to carry pollutants to the TNW, no pollutants have been identified onsite. In addition, it is speculative as to the significance of the impacts of any unknown pollutant on the chemical integrity of the TNW. This reach does not provide significant habitat and/or lifecycle support functions for fish and other species that are present in the TNW due to the ephermal nature. The reach is not critical habitat for any state or Federal listed species. The relative reach does not support a fishery. Since the reach also drains quickly it is unlikely that the reach supports macroinvertebrate populations that would have a significant affect on the TNW. Since the**

riparian area adjacent to this reach is primarily fescue, it does not provide habitat and has minimal effects on control erosion and dispersion of flow energy. Due to the ephemeral nature and size of the watershed, these benefits are minimal. Due to the fact that the riparian area adjacent to this reach consist of fescue, the relevant reach's net affect on biological functions of the TNW downstream would be insubstantial. The wetland within this relevant reach is located at the head of the reach, with not discernible OHWM above the wetland area. The lack of OHMW indicates the upper portion of this reach does not have a hydrological connection to the downstream reach through the wetland. Any effect this wetland would have on the chemical, physical or biological integrity of the TNW would be speculative due to the low quality and function. In addition, no evidence was found to indicate that these waters are used by interstate or foreign travelers for recreational or other purposes, no fish or shellfish can be taken and sold in interstate or foreign commerce, and no industrial uses have been identified for interstate commerce. Therefore, these waters lack a connection to interstate or foreign commerce. In conclusion, based on current guidance and instruction, we are not able to demonstrate that there is a significant nexus between this relevant reach and the TNW and is therefore not jurisdictional.






