

Proposed Plan Fact Sheet Former Forbes Atlas Missile Site S-5 Lyon County, Kansas

You have the opportunity to provide comments on the Proposed Plan for the Former Forbes Atlas Missile Site S-5 (S-5 Site) in Lyon County, Kansas. The United States Army Corps of Engineers (USACE), with the support of the Kansas Department of Health and Environment (KDHE) and the United States Environmental Protection Agency (USEPA), has issued the Proposed Plan and would like to hear your views on it.

The Proposed Plan summarizes the results of the investigations and previous response action which demonstrates that the S-5 Site poses unacceptable risk to human health for future residents. The recommended final action in the Proposed Plan is In-Situ Treatment with Long-term Monitoring and Contingent Alternate Water Supply for the S-5 Site. The public is invited to participate in the decision-making process by providing comments on the Proposed Plan. The final action will be selected after review and consideration of public comments.

The S-5 Site was an operational intercontinental ballistic missile launch facility from 1959 to 1965. The Atlas Missile Program was an important but short-lived element of the United States' defense system. The S-5 Site was one of nine (9) former Series "E" Atlas Missile Sites located around Forbes Air Force Base (AFB), Topeka, Kansas. The site is surrounded by agricultural grazing lands.

Environmental contamination at the S-5 Site resulted from waste management practices during the facility's operational period. Much of this is groundwater contamination beneath the site. Contaminants in the soil were not detected above respective screening criteria. Sediment and water samples taken the main sump, sediment trap, flame tunnel, and various pits located in and around the missile base structure, were determined to be potentially a source of groundwater contamination at the Site. In 2018, an Interim Remedial Action was performed to remove the water and sediments from the sump, sediment trap, and flame pit structures.

The site has been investigated by both USACE and the USEPA as documented in the following reports, which are available as part of the Administrative Record:

- 1991 USACE Confirmation Study
- 2007 USEPA Preliminary Assessment
- 2018 USACE Remedial Investigation
- 2018 Interim Remedial Action
- 2020 Feasibility Study
- 2021 Proposed Plan

What is the remedial alternative?

In-Situ Treatment with Long-term Monitoring and Contingent Alternative Water Supply is selected because it would provide destruction of volatile organic compound mass in groundwater and provide data to evaluate treatment progress. Monitoring will continue until remedial action objectives are achieved. A contingent alternate water supply is included in case land use is changed to residential and would prevent direct exposure to contaminated groundwater.

Public comments will be reviewed by the USACE and considered in the selection of the final remedy. All comments will be evaluated. Afterwards the selected remedy will be published in a Decision Document (DD). The USACE will respond to comments in a section of the DD called the Responsiveness Summary.
