### **Day Use Fees**

The Corps of Engineers was authorized to collect day use fees at Corps operated and maintained parks by the Omnibus Budget Reconciliation Act of 1193 (Public Law 103-66). Areas leased to other entities or private concessionaires are not included in this authority.

A daily fee of \$5/private vehicle is charged at developed swimming beaches. Children 16 years of age or younger are free. A daily fee of \$5/launch is charged at boat ramps that have restrooms, security lighting, courtesy docks, or other recreation facilities.

Registered campers in Milford Lake Corps parks do not pay the additional day use fee; their camping fee covers this charge.

Annual Day Use Fee Passes may be purchased for \$40. The Annual Passes are valid nationwide at any Corps day use fee park for boat ramp and swimming beach fees. These passes may be purchased at the Milford lake Project Office/Information Center.

#### **Recreation Use Fees**

Federal law provides for the charging of special recreation use fees at designated U.S. Army Corps of Engineers recreation areas.

### **Camping Fees**

At Milford Lake the Corps of Engineers charges camping fees at two different levels.

**Class A** parks have flush restrooms, showers, trailer dump stations, designated tent or trailer spaces, refuse containers and drinkable water.

Class C parks have vault toilets, designated tent or trailer spaces, refuse containers and drinkable water. Drinking water provided in Timber Creek Park only

<sup>\*</sup>Note: Both School Creek and Timber Creek Parks are open to free camping/no services provided from October 1 - April 14. Free camping is also available in West Rolling Hills Park year around (see a copy of the Milford Lake Brochure for locations).

Camping Fee Policy: Fees are charged on a per/site basis. Only one camping unit per/site is allowed. A camping unit can be a motor home, trailer, vehicle camper or tent. Each camping unit is allowed one additional tent per/site without further charge. There is a limit of two camper vehicles per/site and no more than two visitor vehicles per/site at any time. During holiday weekends exceptions may be made to this policy to accommodate co-sharing of a specific site. Only one unit may connect to utilities and the co-sharing unit will be charged the basic site fee (non-electric charge for that specific campground).

**Sewage Dump Station:** There is a \$2.00 fee to use the sewage dump station at West Rolling Hills, Curtis Creek and Farnum Creek if you are not a current, registered camper in that campground.

**Day Use Fees:** (Annual Day Use Fee Passes - \$40.00) Fee Season: 4/1 - 10/31

Boat Ramp: \$5/day/boat launch

Boat Ramp fees are collected at the following ramps: Curtis Creek, West Rolling Hills, Farnum Creek and School Creek. The Timber Creek and East Rolling Hills ramps are free.

Beach: \$5 per vehicle or \$2 if walk in or bike. Fee Season: 5/15 - 9/15

Beach fees are collected at East Rolling Hills and Outlet Parks. Children 16 & Under are free.

Picnic Shelter Reservations: \$25/day, except ERH shelter #1 \$50/day Fee Season: 4/15 - 9/30
